For the non-residential consumers including but not limited to industrial, commercial, and business use, the faucet products are warranted for a period of **5 years** from the original date of purchase. This warranty is non-transferable to subsequent purchasers or owners. The sole exception to the non-transferability of this warranty is that if this product is purchased by a plumber, contractor or other service provider, this warranty extends to the first property owner on whose behalf the product was purchased for installation.

If the faucets should leak or drip during normal usage, Mifflin Kitchen & Bath will, free of charge, mail the parts necessary to put the faucets back in good working condition and will replace any part, free of charge, that proves defective in material and/or manufacturing workmanship.
